

How to Choose a Cannabis Product

Gannabis is a flowering plant that has leaves, flowers, and roots used for medicinal purposes, and seeds used for food and fuel oil. Cannabis can be consumed in several forms: dried flower buds or various types of concentrated, loose, or pressed resin extracted from the flowers or leaves through a variety of methods. Once mature, the entire plant contains and is covered with tiny glands of resinous oil containing cannabinoids and terpenes that provide physical and psychoactive effects.

Cannabis comes in many varieties, roughly divided between Sativas that originated near the equator and Indicas that come from northern latitudes, though modern breeding programs have created a wide range of Hybrids. Each variety has its own cannabinoid and terpene profile and subtly different effects. Whether you use Sativadominant, Indica-dominant, or a Hybrid it makes a difference.

Cannabis Sativa is used to produce feelings of stimulation, and is often used in daytime. Some of the therapeutic effects of sativa use include —

- Stimulating/energizing
- · Increased sense of well-being, focus, creativity
- Reduces depression, elevates mood
- Relieves headaches/migraines/nausea
- Increases appetite

Cannabis Indica has a tendency to produced sedated feelings in the body and is preferred for use at night. The therapeutic effects are —

- Provides relaxation/reduces stress
- Relaxes muscles/spasms
- Reduces pain/inflammation/headaches/migraines
- Helps sleep
- Reduces anxiety
- Reduces nausea, stimulates appetite
- Reduces intra-ocular pressure
- Reduces seizure frequency/anti-convulsant

Cannabis use produces different effects with different people and sometimes there are side effects. It is recommended a first-time user of a new product of cannabis consume in small quantities. While considering if one should consume cannabis products, three important questions should be asked beforehand to determine the best product to consume:

• Why consume? What sensation is the individual seeking?

• What product types match with desired outcomes and comfort level of consumption.

• Will the consumption of cannabis products contraindicate or have an adverse effect while used in combination with other medications or life-style choices. (These questions are best answered by your doctor or pharmacist.)

There are a wide range of legal cannabis products to choose from. The most common form is the dried flower or bud from the female plant. There are also extracts or concentrates of the cannabis plant, which are made from cannabinoid-rich glandular trichomes, found in varying amounts on cannabis flowers, leaves, and stalks. **KIEF**

Kief is a powder made from trichomes removed from the leaves and flowers of cannabis plants. Can be compressed to produce





cakes of hashish, or consumed (typically smoked) in powder form in a pipe or with cannabis bud or other herbs.

HASHISH

Hashish (also known as hash or hashisha) is a collection of compressed or concentrated resin glands (trichomes). Hash contains the same active cannabinoids as the flower and leaves but typically in higher concentrations.

CANNABIS EDIBLES

Cannabis can be ingested or eaten when added to cake, cookies, dressings, and other foods. It can also be brewed into a tea or other beverage. To be effective, cannabis and its extracts or concentrates must be heated in order to convert the cannabinoid tetrahydrocannabinolic acid into active THC. **CANNABIS OIL**

Cannabis Oil (cannaoil) is cooking oil infused with cannabinoids.

Various means to extract include heating the oil and cannabis mixture at low temperature in a frying pan or pot, double boiler, or slow cooker then straining out the plant material. Can be used in any recipe that includes oil and that doesn't go over 280 degrees Fahrenheit (evaporating point). Think cookies, cakes, candies, and other food items. **CANNABIS BUTTER**

Cannabis butter (cannabutter) is butter infused with cannabinoids. Heat raw cannabis with butter to extract cannabinoids into the fat. Various means to extract include heating the butter and cannabis mixture at low temperature in a frying pan or pot, double boiler, or slow cooker then straining out the plant material. It can be used in any recipe that includes oil and that doesn't go over 280 degrees Fahrenheit. **TINCTURE**

Tinctures use ethanol alcohol (e.g. pure grain alcohol, not rubbing alcohol) to extract the cannabinoids. You use droplet

amounts, and it is absorbed through the mucous membranes in the mouth. **SPRAY**

Sublingual sprays are another way of using a tincture. Use ethanol alcohol to extract the cannabinoids. You use a pump to spray cannabis-alcohol solution under your tongue.

CANNABIS LIQUOR

Liquor may be infused with cannabinoids. Best to cook stems and leaves into brandy or rum. It can also be added to coffee and other beverages.

CANNABIS TOPICALS (APPLIED TO THE SKIN)

Cannabinoids combined with a penetrating topical cream can enter the skin and body tissues and allow for direct application to affected areas (e.g. allergic skin reactions, post-herpes neuralgia, muscle strain, inflammation, swelling, etc.).

Cannabinoids in cannabis interact with a humanoid's endocannabinoid system. Part of the endocannabinoid system, including CB1 and CB2 receptors, are found all over the body, including the skin.

Both THC and Cannabidiol (CBD) in topical creams have been found to provide pain relief and reduce inflammation, but topical cannabis use does not produce a psychoactive effect, which is different from eating or inhaling the medicine. Both creams and salves are used for a wide variety of conditions, and produce antiinflammatory and analgesic relief.

Check your local cannabis dispensary to find out more information, and see what products are offered. Dispensary staff there can provide helpful advice and recommendations for appropriate use.

lowers speak a universal language. They have tremendous power to communicate emotions and meaning. As gifts, flowers say a lot about the giver, as well as the recipient. As ornaments, they say a lot about an occasion or event.

Flower bouquets make an ideal gift for many varied occasions: a housewarming, wedding, corporate dinner, birthday party, anniversary or holiday. The beauty of a floral arrangement can brighten up any room. It evokes an atmosphere of happiness and celebration.

Selecting the perfect flower arrangement can be the key to creating just the right atmosphere. And a professional florist is your go-to source to help you arrive at the right combination of colors, types of flowers and even scent. Together, they will all work to make your occasion special. When you're in need of a florist, think about these tips.

RESEARCH THE FLORIST

For an event at a venue, find out from the venue staff what they recommend. They see a lot of celebrations, and are usually quite familiar with the best local florists. But be proactive: popular florists usually stay very busy year-round. It pays to start the process of consulting with your florist as soon as you possibly can.

Talk to family and friends. They often have helpful suggestions. Remember to ask them about their own experiences with

Equipped with a narrowed-down list of florists who are available, it's now time to visit their shops and interview them. **INTERVIEW THE FLORIST**

Observe the shop when you get there. Are the pathways clear of plants, tools and debris? Is the staff friendly and warm? The answers to these questions will help you understand each shop's level of customer service and care they give to their products.

All plants and flowers should be well-maintained and attractively arranged. Employees should be attentive. The best florists have a wide range of options in their showroom.

During the interview, ask if the florist has previously worked at your venue. Each facility has unique rules about what they will allow in their location. If the florist has worked at the venue. that is a big advantage. They



will know and can adhere to the rules.

Inform the florist of your budget and ask for recommendations. The florist should be able to give you numerous suggestions about flower arrangements.

Most florists have a scrapbook of their previous work. Each professional brings a sense of personal style to her arrangements.

Be sure to show the florist your notebook. Discuss the arrangements you prefer. Perhaps the florist could produce similar arrangements.

Once you have chosen your florist, be certain to confirm the type of arrangements you will receive.

You should also know when the arrangements will arrive at the venue and who is responsible for placing the flowers in the appropriate spots. Confirm when payment is expected. Understand the floral contract before signing anything.

GET IT IN WRITING

When you are pleased with a company's work, you might assist the shop with providing positive references and reviews.

A professional florist will help you go a long way toward establishing the right environment for your event. The vivid colors and pleasant aroma will convey the right feeling for your special day.

HOW to Choose the Right Dentist

Some people are afraid of dentists or of pain. If you have any concerns, communicate with the staff and dentist. Many professionals are willing to go above and beyond to help you work through these issues.

A basic oral health history should be taken by the dentist or staff. They should tell you about future treatment and prevention options. A quality dentist will help you feel comfortable during your visit.

The best dentists offer friendly, happy dental experiences. Teeth are extremely important to your overall health. They can also help or hinder your appearance. Finding a good dentist is like finding a friend who consistently brings out your best smile.




They work better for people than do clear aligners, a slower straightening technique.

Holistic veterinarians are different from conventional veterinarians. For that reason, holistic veterinarians have sought answers in widely varying areas of non-traditional or integrative health care, especially when patients suffer from chronic or unresolved health problems. Often it is the combination of Western and holistic veterinary medicine is the most successful in treating patients — a true holistic approach.

Some holistic veterinarians consider each patient and his or her case to be unique. While two different animal patients may present with similar symptoms, their respective treatments may be quite dissimilar. Diseases are sometimes seen as a natural course of life and not necessarily something to 'solve.' While diseases may be real, they do not have to be a natural part of life.

Holistic veterinary practice is centered on keeping the pet healthy overall to prevent issues from starting, as well as treating diseases. When a chronic issue surfaces, holistic veterinarians are likely to look for herbal supplements, whole food diets, complementary and alternative therapies to treat the pet.

Holistic medicine is about finding the root cause of a problem and treating from there, not simply treating the symptoms. Often the underlying causes of disease can be allergies, inflammation, infections, metabolic imbalance, or nutritional deficiencies. If those are not addressed, the problems will return again, even though the symptoms have been treated.

For example, an animal that has developed symptoms of chronic would not necessarily be given antibiotics and steroids to mask the symptom of bloody diarrhea, unless it would truly help the patient.

Instead, treatment might be to use other modalities such as homeopathy, herbal remedies, vitamin/mineral supplementation and other non-toxic, alternative options to restore metabolic balance and true health.



Choosing a holistic veterinarian is much like choosing a traditional veterinarian. You can ask for referrals from friends and family, or check online.

The American Holistic Veterinary Medical Association is a great resource. You can check their website — www.ahvma.org/find-a-holistic-veterinarian/ to find a holistic veterinarian near you.

Different holistic veterinarians offer different modalities and techniques. It is important to find one that both you and your animal are comfortable with. Don't be afraid to ask questions. For many of us, our animals are members of our family, and their health and well-being is of utmost importance.

HOW to Choose a Home Repair -2019 – **Professional**

ASK THE RIGHT QUESTIONS

Ask questions before agreeing to use the services of a contractor. You're embarking on a business transaction. You are interviewing this professional to perform a service for you, so regard it as a job interview.

You should know the contractor's experience, background and expertise. Sometimes contractors will hire others to perform jobs for them. You have a right to know who is in your home and on your property at all times. Ask who will be performing the actual work.

The contractor should have proper licensing. Most states require all general and specialty contractors be licensed and registered in the state where they perform work.

Verify the contractor has insurance. Ask to see the certificates. Also, the contractor should show you the proper permits before work begins.

GET EVERYTHING IN WRITING

It's important to start a paper trail early in the process. Avoid unexpected expenses by requesting a written estimate before work begins. This detailed estimate should describe all fees, expenses, and costs. It will avoid confusion or disagreement later.

Your written estimate will also tell you if there is cleanup or repainting included in the project? Inquire about any additional finishing touches, such as wood trim or drywall restoration.

When a bid sounds too good to be true, investigate. When professionals are interested in getting the job, they may provide you with unrealistic estimates. After work is completed, homeowners may find the contractor used second-rate materials or skimped on labor. It is vital that only quality materials are used during your project.

A low bid may also indicate that the contractor is unqualified or not licensed for the job. A written estimate will give you valuable legal evidence should a dispute arise. Save all estimates and receipts related to the project.

BACKGROUND CHECK

Perform a thorough background check on the contractor. Make sure they have all the certifications and business licenses required. Ask for a list of previous clients, and contact the clients to ask about their experiences.

The Better Business Bureau (BBB) will also inform you about the contractor's work history, and also tell you if there is a record of formal complaints filed against the contractor and whether the complaints were resolved.

Finally, all professional contractors are bonded. They carry insurance against accidental property damage as well as personal liability coverage.

WARNING SIGNS

There are specific warning signs you should know before hiring a contractor to perform home maintenance or repairs.

The most important sign is when a contractor uses pressure tactics to secure a contract. Contractors might intimidate the homeowner into making an immediate hiring decision. Wait until you feel comfortable.

Another red flag would be the contractor insisting you pay a large portion of the bill in advance. Pay the bill in portions as work is completed. Only pay the last portion when you are completely satisfied with the finished work.

Anyone who only accepts cash as a form of payment should be considered extremely suspicious. Always pay by check or credit card and get a detailed receipt.

By taking time and following these guidelines, you can be confident that the repair job will be completed to your satisfaction.

In fact, shopping for appliances can be fun. These days, appliance manufacturers produce items that have every conceivable feature to make your life easier. Exploring these innovations in home appliance technology can be an enjoyable and eye opening experience.

Many stores also have message boards for customers to leave comments and reviews for the services and the products they sell, which can give you some insight into the business and their products.

LOOK FOR ADS

Who wants a deal? Well, most of us probably do and one of the best ways to find those awesome deals is to check for advertisements. Deals can be found in your mail, local newspaper or online. Some appliance stores offer specials on certain products.

Other stores will use price-matching to stay competitive. Not all stores have policies on price-matching, so be sure to ask first. If you can find a lower advertised price on the exact same product and model elsewhere, many stores will sell you the product for that price. This is called price matching.

Appliances have a yearly sale price cycle. Washers and dryers usually go on sale during the winter. Refrigerators are often discounted in the spring, and stoves and ovens in the fall. If you don't need it right away, consider shopping seasonally for the best deal.

You could also haggle for a price, especially at a local appliance store. Salespeople are typically prepared for this process. If you are too shy or afraid of haggling, ask the store for an extended warranty or free delivery and set-up. It never hurts to ask. They just might give it to you.

Consider these questions when you're looking for an appliance store: do they have a delivery window, warranty options, repair services and range of products?

When you have these questions answered, then you can purchase your appliances with confidence.

Choose an Auto Repair Shop

the American Automobile Association? If so, this indicates a customer approval rating of 90 percent or higher and the ability to adequately perform the services advertised.

· Compare the services and fees of each shop in the area to find out the average price ranges.

Don't pick a shop based on cost; poor repair work will mean higher costs in the long run.

Once you have found a shop you trust, establish a good working relationship with your mechanic. When you have great communication, getting repair work completed will be less painful.

Choose a Tax Professional

ax time is stressful for millions of Americans. But before you drag out the calculator and attempt to understand a whole bunch of tax code confusion, consider enlisting the help of a tax expert.

A professional tax preparation service can help you file your quarterly or annual tax returns while also navigating increasingly complicated tax codes.

Reliable tax preparer can also save you time and money while helping you avoid errors that get you in trouble with the IRS.

But finding experienced and responsible tax professionals requires research. The IRS urges caution in picking a tax preparation service because the use of the service does not absolve you of problems stemming from an incorrect tax return.

There are many tax preparers who are honest. They provide excellent service to their clients. Others, unfortunately, are less than scrupulous. They cause their clients legal and financial nightmares.

As of 2011, the IRS requires professional tax preparers to register, pass a competency test and meet continuing education requirements.

This government agency also licenses its own Enrolled Agents who must meet the same standards. The Treasury Department authorizes these Enrolled Agents to aid taxpayers at all levels of an audit. Before hiring a tax preparer, verify that they will represent you if you are audited by the IRS. Ask about the preparer's audit rate.

The person you are hiring must specialize in tax preparation. A certified public account might not be a tax specialist, and is no guarantee you will not be audited.

The federal tax code changes every year. It is a challenge for tax professionals to stay current with the changes. A CPA specializing in taxation should have documentations of any continuing education classes completed in the past year.

It is important to check on your preparer's as well as the firm's credentials. The Better Business Bureau will inform you if they have dubious reputations. For more verification, contact your state's board of accountancy or your state bar association's tax lawyers to research a preparer's professional record.

A legitimate and reputable professional tax preparer should have:

• A relationship with an organization requiring continuing

- education
 - A fee schedule based on the complexity of your return
 - The willingness and ability to answer all of your questions

 Availability extending beyond the preparation and filing of your tax return

- Knowledge of your state's tax laws
- Familiarity with any special circumstances that may apply to you



• A willingness to include an itemized list of any judgment calls it has made and attach it to your copy of the return

• A willingness to provide an in-person review of any expected refunds with the preparer.

Warning signs of a disreputable tax preparer may include:

- Claims that they can obtain larger refunds than their competitors
- Guarantees of a refund up front
- A request for your signature on a blank tax form

 An unwillingness to sign a return, known as "ghost" preparation.

The best tax professional has a proven track record of competence, a stellar reputation and an attitude of respect for his clients. It is your financial and legal status at stake. The preparer should be ready and able to stand behind his work and beside you if you ever need to appear for an audit.

Join Ducks Unlimited — Conserving Wetlands & Waterfowl

S cience, research and a strong biological foundation — Ducks Unlimited's (DU) conservation programs have always had a strong biological foundation. That science and research tradition continues today with hundreds of studies to address the habitat needs of waterfowl — there's still much to learn about how the birds respond to landscape, habitat and environmental changes.

DU has embraced an approach of constant monitoring and evaluation which allows for continual refinement of its habitat programs ensuring that every dollar invested in conservation programs is used effectively and efficiently. The following are methods DU uses to conserve wetlands and valuable habitat for North American waterfowl.

Restoring Grasslands — Ducks such as mallards, pintails and teal build nests in dense, grassy areas near wetlands. Grassland cover helps hens conceal their nests and increases their chances of successfully hatching a clutch. Once hatched, the hen leads the ducklings over land to a nearby wetland, where they grow into adults. DU help to secure and restore these grasslands to reduce predation rates and improve nest success.

Replanting Forests — Forests that flood regularly due to overflowing riverbanks, make for ideal wintering habitat for ducks, and provide essential breeding and foraging habitat for other wildlife species. 80% of forests have been cleared for agriculture and other purposes, and rivers have been tamed with dams and levees. DU has reforested more acres in the country than any other organization and worked to restore backwater to these forests to mimic historical flooding.

Restoring Watersheds — A watershed is the area surrounding a wetland, and therefore has a great effect on the water quality and general health of a wetland. When watersheds are disturbed, silt, nutrients and contaminants can be washed into downstream wetlands, impacting the flora and fauna that inhabit these systems. DU restores drained wetlands, protects stream corridors and establishes buffer strips that filter nutrients and silt.

Working with Landowners — Nearly three-fourths of America's remaining wetlands are on private lands so DU works with farmers, ranchers and other landowners to improve the agricultural and recreational value of their land, making it more wildlife-friendly. A new market is developing where landowners can become suppliers of environmental credits that can be sold in a voluntary trading market by adopting certain types of conservation practices on their land.

Working with Partners — No single group could perform the work necessary to meet the goals of the North American Waterfowl Management Plan and DU's International Conservation Plan. DU's projects are done in cooperation with partners including state and federal agencies, private corporations, foundations, and individuals.



Acquiring Land — In special cases, DU will purchase property then restore its value to wildlife. Once the habitat work is complete, DU will then sell or donate the property to a government agency that will manage it for wildlife.

Conservation Easements — Some of the most valuable wildlife habitat is threatened by development. DU's Conservation Easement Program is designed to protect habitats forever through agreements with landowners.

Management Agreements — DU offers financial incentives to landowners that manage their land for waterfowl and other wetland wildlife. The landowner receives a number of benefits under this type of agreement, and hundreds of wildlife species are insured quality habitat.

Geographic Information Systems — Geographic Information Systems (GIS) technology enables DU to determine where our habitat work will be most effective as well as monitor the results of our work. Combining satellite images with wetland inventories, land-use practices, soil type, wildlife use and more; DU's GIS specialists help identify the best places to restore or protect habitat on the landscape.

Grow an Organic Vegetable Garden

t's official, organic food gardening is the hottest trend in home gardening right now! Not only can this help reduce our grocery bills, now growing your own food means eating better. We all want to know that the food we're putting in our bodies is as healthy as possible — and homegrown food simply tastes better.

If you're like the other 21 million people in North America who will be starting a vegetable garden this year for the first time, chances are a few time-tested tips will come in handy. A home vegetable garden is easy to start and doesn't require as much effort as one might think to keep it growing strong. Following a few simple steps will ensure you're enjoying the fruits of your labor in no time.

Location is Key — Most vegetable plants do best in full sun. Find a location that gets at least six hours of it each day if possible. In order to provide the most sun exposure to all your plants, place the tallest ones, such as corn, indeterminate tomatoes or pole beans on the north or west side so they do not shade the smaller plants.

Garden Boxes — If you don't have the luxury of growing a garden on open land, look into building some simple garden boxes complete with access to water and drainage. Always be sure to plan out where to place your plants so that the support each other through natural pest control and shared rooting space. Give consideration to using some type of small fencing around your garden box to keep pests and pets out. It's All About the Soil — The best soil suitable for vegetables includes lots of compost and organic matter such as composted leaves and ground or shredded, aged bark. Whatever you're starting with, incorporate enough organic material so that the amended soil is neither sandy nor compacted. When the mix is right, it will bind together when you squeeze it but breaks apart easily when disturbed helping with water retention and healthy living microorganisms that help feed your plants.

Seeds — **the Source** — There are numerous sources for organic seeds available at your local farmers market, garden center or online as well as from local farm stands. Avoid seeds that have been genetically enhanced and opt for natural. Seeds garnered from local or regional farmers or farmers markets are best suited for your local growing conditions.

Water Wisely — For most vegetable plants, one inch of water per week, including natural rainfall, is adequate. Irrigate using soaker hoses and drip lines that deliver water slowly, on target allowing roots time to absorb the moisture and soil. Wet foliage for extended periods can promote diseases. Automatic timers are a great way to take the effort and worry out of this all important step.

Use Organic Mulch — Add a three-inch layer of any organic mulch around your plants and over the irrigation lines if possible. Mulch will insulate the soil, helping to keep it cooler in summer and warmer in winter. It also helps retain moisture, suppress weeds and

acts as a protective barrier from diseases splashing up onto the plants from the soil. Mulch looks great in the garden.

Knowing the source of your mulch is as important as using it — some mulch can contain unacceptable amounts of harmful



chemicals — read labels on soils to ensure that what you use is free of any harmful ingredients.

Use Patience with Pest Control — Although pests are usually a given at some point in any vegetable garden, by exercising patience, nature will usually take care of the problem. Of all the insects in your garden, only about 3% are actually harmful pests. Practicing the steps mentioned so far takes adequate measures to promote the growth of healthy plants which are better able to stand up to potential pest invasions.

If you must resort to pest control, there are numerous natural and organic solutions available today. Use these only late in the day or evening and then only when necessary. Never apply in the morning when pollinators and beneficial insects are most active. Focus on growing healthy plants with great soil and sunny conditions and let nature take its course.

Don't Over Fertilize — Too much natural fertilizer, especially nitrogen, can promote plenty of lush green growth at the expense of less fruit and a smaller harvest. Excessive fertilizer can also be harmful to your plants and the soil. Add only as much organic compost as needed, up to about 20% of the total soil makeup. You'll be supplying your plants with the nutrients they need to thrive naturally. Feed the soil and let the soil feed the plants.

If you put these tips into practice, you'll get your organic garden off to the right start and set it up for a fruitful season. Preparation is key with the reward being a healthier, more productive garden.

How to Choose a Solar Energy Company

ower your home energy bills while increasing the property value of your home or business by adding solar panels to help you meet your electricity needs. Technological advances in recent years make the environmentally options more affordable and convenient than ever.

Best of all, the type and cost of the solar panel system you install can be tailored to meet your specific needs.

In addition to the help from government programs, there are three ways buyers typically purchase their systems:

• **Paying cash:** The simplest and most direct way of paying for your system, cash buyers may be eligible for a 30 percent tax credit from the federal government along with other rebates that can reduce the installation cost up to 50 percent in total.

• Loans: Both home equity loans and unsecured solar loans may be available to help you purchase a solar system. Some solar companies offer loans for up to 20 years, while home equity loans may have the benefit of letting you deduct the interest from your income taxes.

• Leases: You may also be able to lease your solar system with no down payment or upfront costs. A solar lease will let you make affordable monthly payments to pay for your system, perhaps even including a performance guarantee and scheduled maintenance services included in the monthly cost.
