

# **Every Picture Tells a Story**

Harnessing the power of visual storytelling, Harford County's OCED has created a toolkit of videos geared to the business community.

To attract new businesses, OCED developed a humorous video that highlights Harford County's major assets: strategic location, highly-skilled workforce, and quality of life. The video, titled "Come Find your Future in Harford County" features movie-quality production and stunning visuals, without taking itself too seriously: "We're not just cows and trees, we're cutting edge!" Another video, "Greatness Awaits", is a one-minute overview that packs plenty of specifics: Harford County is home to Ripken Baseball and to Aberdeen Proving Ground (APG) which has the nation's highest concentration of advanced degrees of any military installation. Both videos are used to market the county to business prospects, and are posted on social media and the county website.

A series of four videos produced by OCED raise awareness about APG, Harford County's largest employer, and promote Harford as a Great American Defense Community. The videos use

high-definition imagery, drone footage, and animation to offer insight about life in and around the Army installation. All four videos are posted on a new website that was also created as a result of the JLUS project, https://apg-chesapeakejlus.com.

# HAVING FUN MAKING MONEY TOURISM BRINGS REVENUE, JOBS TO HARFORD COUNTY

**O**ne million dollars a day. That's the economic impact of Harford County's 2 million annual visitors - and it's no wonder given the county's exciting and diverse attractions.

"Harford County has the waterfront in historic Havre de Grace, international cuisine, craft wine, beer, and spirits, farmers markets, and unique boutiques," Greg Pizzuto, executive director of the nonprofit Visit Harford, said. "Outdoor enthusiasts will find more than 80 county parks and three state parks, with hiking, biking, and birding adventures."

The county's most popular attraction is Ladew Topiary Gardens in Monkton, drawing 45,000 people annually to its world-renowned flower gardens and larger-than-life topiary forms. The county's most popular annual events are the Maryland BBQ Bash in Bel Air and the Darlington Apple Festival, celebrated

along Main Street in Harford's most charming rural towns. Harford's scenic views also make it a popular wedding destination; top quality playing fields make it a hotspot for youth sports, and new attractions are always on the horizon.

# An Overnight Destination

Harford County has a variety of options for guests to relax and stay awhile. Visitors can choose everything from historic, waterfront bed and breakfasts to more modern accommodations. Under the administration of County Executive Barry Glassman, these overnight stays also help to fund the attractions that draw visitors to Harford in the first place.

Funded with a 6% hotel lodging fee, the county program is dedicated to nonprofits that directly support tourism activities, especially those that will



attract overnight hotel guests. This competitive funding program directly supports cultural, historical, museum, eco-tourism, and sportstourism activities.

More than 30 organizations have received awards through the program in the last four years, totaling more than \$6 million dollars for tourism-related activities since inception in 2015. In 2017, hotel stays increased to 909,700, a 2.8% increase from the prior year.

Among the drivers of these hotel stays is Harford County's reputation as a popular wedding destination. Picturesque venues, including the Liriodendron Mansion, Swan Harbor Farm, Rockfield Manor, and Top of the Bay, among others, attract couples to exchange their vows and celebrate with their families and friends. A couple's big day, and their guests, also generate a ripple effect for local vendors, restaurants, and shops.

# **Small Players, Big Business**

Harford County's central location and first class sports tourism amenities have made it one of the region's premier sites for largescale youth sports tournaments.

For weekends at a time, youth sports tournaments draw athletes, their families, and fans to make Harford County their "home away from home." With an abundance of post-game activities and easy access to regional amenities, these tournaments also bring big business to the local economy. In each of the past three years, sports tourism has created a nearly \$50 million economic impact and has supported 650 jobs in Harford County, according to a recent study commissioned by Visit Harford.

# AMMP PLANTS ROOTS IN HARFORD COUNTY FOR ADVANCED MANUFACTURING EPICENTER

The science of next-generation manufacturing arrived in Harford County in October 2018, as leaders in government, industry, and academia welcomed the National Center for Manufacturing Sciences (NCMS) and the launch of its Advanced Manufacturing, Materials, and Processes (AMMP) program. Through agreements between NCMS and the U.S. Army Research Laboratory - known as Other Transaction Authority (OTA) and a Cooperative Agreement (CA) - plans are in place to deliver advanced manufacturing technology that fortifies foundational components in defense and aviation critical to our national security.



In March 2019, representatives from NCMS, ARL, and Harford County's Office of Community & Economic Development co-presented the AMMP initiative at the Association of Defense Communities Installation Innovation Forum in





Miami FL, which recognized AMMP with their nationally known Innovators Award. In September, NCMS also hosted an NCMS Technology Showcase at Aberdeen Proving Ground, attracting more than 60 companies to spotlight innovative technologies and capabilities.

Throughout 2019, in-depth, customized space considerations were closely examined, and a partnership grew among Department Maryland of Commerce, Harford County Government, the Maryland General Assembly, and U.S. Senator Chris Van Hollen's office to support NCMS in its effort to plant roots in Harford. The goal of this endeavor is to develop a physical location to support the right combination of demonstration and lab space conducive for teaching the digital ecosystem and facilitating infrastructure for, and access to, non-commercially

available 3D printing equipment. Upon consideration of numerous alternatives, NCMS is pursuing a multi-year, private investment within Harford County to establish the Advanced Manufacturing Collaboration Center (AMC2). An official opening for AMC2 is anticipated in the summer of 2020. •



# DEFENSE E TECHNOLOGY: A YEAR OF INNOVATION AT WORK

# JANUARY

The Office of Community & Economic Development (OCED) partnered with the MD Department of Commerce in expanding the **Maryland Defense Technology Commercialization Center (DefTech)** program. DefTech is an endeavor that promotes tech transfer and commercialization of technology developed on Aberdeen Proving Ground (APG). After a successful one-year pilot, DefTech now has locations near APG, Ft. Meade, and Ft. Detrick. OCED continues to host DefTech in Havre de Grace.

# **FEBRUARY**

The Chesapeake Science and Security Corridor (CSSC) consortium, comprised of partner organizations across Maryland, Delaware, and Pennsylvania, convened at in Harford. The meeting was to formalize the re-signing of a Memorandum of Understanding confirming CSSC's commitment to support Aberdeen Proving Ground and economic vitality for the surrounding communities. Harford County serves as the lead agency in the 50+ organizations in the CSSC.



# MARCH

OCED hosted a **Defense Contractors' Breakfast** at Water's Edge Events Center, which focused on **connecting defense-related companies with business resources**. 14 federal, state, and local government officials and non-profit representatives provided subject matter expertise.

# **SUMMER & EARLY FALL**

- A series of **ribbon cuttings for Harford County defense and IT companies** occurred: ANSER and GSI Technologies in Belcamp; and Ad hoc Research Associates and ITekFed in Havre de Grace.
- Harford Community College, with Harford County Public Schools and APG, was awarded the Pathways to Technology Early College High School (P-TECH) program, the first to garner support from a federal agency.
- The Joint Land Use Study (JLUS) competed its second phase with three studies: the Susquehanna River Impacts & Accretion Study; an Economic Impact Analysis of the Army's chemical, biological, radiological, nuclear, and explosives (CBRNE) mission activities located on APG South in Edgewood; and a Transit-Oriented Development Study. A JLUS website launched to showcase the study's findings and the corresponding four-part video series.

# SEPTEMBER

Harford County was featured in the **Economic Alliance of Greater Baltimore's** Region on Point video series, spotlighting the county's defense sector and advanced manufacturing partnerships.



# **BUSINESS SUPPORT**

Defense and IT companies may be eligible for three cyber tax credit programs as well as the HireVets program. At the local level, there are workforce technical training Grants (WFTTG), Enterprise/Opportunity/Hub Zones, tech attraction loans and, for those on the Route 40 corridor, revitalization loans. # JUNE

- The Regional Additive Manufacturing Partnership of Maryland held a Metals Additive Manufacturing Symposium to explore where additive technology is going and what resources are currently available to agencies and manufacturers.
- The Northeastern Maryland Technology Council launched TechKey and iDisruptor at the Battelle Eastern Science & Technology Center. These two serial tracks take a deeper dive on disruptive technologies like Google AI, 5G networks, and medical cannabis.
- Maryland's Regional Manufacturing Institute hosted "Why Maryland Manufacturing Matters". OCED attended to support a spotlight on Dunlop Protective Footwear, the only maker of polyurethane boots in the U.S., which is headquartered in Havre de Grace.

# **APRIL**

Nearly 800 attendees participated in **APG's Advance Public Briefing to Industry**, which provides an outlook on government contracting opportunities with APG. OCED presented along with the Maryland Department of Commerce on a general session panel, and also supported APG's Office of Small Business Program's one-on-one session with a briefing of local resources.

# MAY

Maryland Department of Commerce Secretary Kelly Schulz visited Harford County. Technology was the focus of a visit to Smiths Detection, a global leader in threat detection and security screening. The company's U.S. headquarters is in Edgewood.

# OCTOBER

Representatives from the **Chesapeake Science & Security Corridor** toured APG and heard from officials about construction, mission growth, workforce opportunities, and innovation happening on the installation.

# NOVEMBER

OCED supported one of its colocated partners by attending the **Army Alliance's Annual Breakfast**. Army Alliance serves as Harford and Cecil Counties' arm for defense advocacy. The organization garners support for modernization on APG through demolition of old buildings, funding for an emerging threat center, maintaining APG's status as an innovation hub, and biomanufacturing expansion.

# DECEMBER

The U.S. Army Network-Cross Functional Team celebrated a ribbon cutting to operate an office outside the APG gate focused on business resource partnerships, joining the continuum of small business resources at the OCED-run Harford Business Innovation Center.





Harford County is home to Aberdeen Proving Ground (APG), the U.S. Army's premier research & development installation employing 21,000 military and civilian workers both at the installation and in subordinate commands. APG, Maryland's sixth largest employer, had a \$5.1 billion national economic impact in 2018.

# HIGHLY-SKILLED WORKFORCE

Within a regional workforce of 1.5 million, Harford County alone has a civilian workforce of more than 137,000; nearly 93% of whom are high school graduates and 34.5% of whom have a bachelor's degree. Aberdeen Proving Ground, the county's largest employer, has the nation's highest concentration of advanced degrees.



Harford County invests in housing and community development, including more than \$11.9 million in FY19 to improve infrastructure and provide funding for human service programs affecting more than 20,000 citizens. The 2017 median household income is \$83,445.



Harford County government is fiscally strong and open for business, with an online permit center, fast-track permitting, financing programs, enterprise zone incentives, site selection assistance, incubator space and easy access to Open GIS data. VVI HARF COUI One-third of the U.S. population is accessible in an overnight drive from Harford County's ideal location on the I-95 corridor. Multimodal transportation options include local and interstate bus routes, rail, global shipping, Baltimore-Washington International Airport, and the Port of Baltimore.

# GROWING AGRICULTURE & AGRIBUSINESS

Agribusiness is growing in Harford County, including craft breweries, wineries, creameries, farmers markets and special occasion venues. The county government has protected more than 50,000 acres of farmland from development to facilitate the supply of farm fresh foods to restaurants and shops locally and nationally.

# EXCELLENCE IN EDUCATION

With award-winning schools, special programs in engineering and biomedical sciences, and a student body that consistently outperforms state and national averages, Harford County has a tradition of excellence in education. Harford Community College is a designated cybersecurity Center of Academic Excellence, offering more than 80 other degrees and certificates, plus on-campus access to four-year degrees.

# HEALTHY HARFORD

Three major medical centers and an expanding healthcare sector serve Harford County residents, 96% of whom are insured. The result: Harford County is healthy, ranking in the top quartile of Maryland jurisdictions for a range of health factors.

# UNIVERSITY OF MARYLAND UPPER CHESAPEAKE HEALTH

- Plans for a **freestanding medical center** in Aberdeen, containing a proposed 24/7 Emergency Department, short-stay medical beds, imaging technologies, medical offices, and a behavioral health facility.
- Projected cost of the entire project is \$54 million.
- Purchased an existing, 95,250-square-foot office building for \$18 million to be outfitted and used for medical offices, with an additional 120,000 square-foot building under construction in 2020.
- Planned **two-floor expansion** at the Bel Air campus.

# THE KLEIN FAMILY HARFORD CRISIS CENTER

- A 24-hour behavioral and mental health and addiction treatment center with services including a 24/7 hotline, mobile crisis team, a behavioral health walk-in urgent care clinic, and observation patient beds.
- A 15,000-square-foot facility that introduced 15 jobs and \$3 million in capital investment to Harford County.
- Estimated to treat **2,000-3,000** patients annually
- Co-funded, public/private partnership.
- Opened in June 2019 and crisis residential beds in August.

# LORIEN HEALTH SYSTEMS



- **\$7.7 million expansion** into Bel Air location in 2019.
- **66,000-square-foot expansion** included 34 new assisted living apartments, 48 new beds, and a state-of-the-art rehabilitation facility.
- Lorien operates three locations across Harford County with more than **450 skilled employees** in total.



# HOW SUCCESSES SU

The GroundFloor is Harford County's dedicated launch pad for entrepreneurs looking to start and grow businesses. Located just 1.5 miles outside the gate of Aberdeen Proving Ground and co-located with the Harford County Office of Community & Economic Development (OCED), The GroundFloor is a co-working space and business incubator surrounded by startup support and collaboration opportunities.

# Neighbor to the Army's "Home of Innovation"

The GroundFloor has historically been used by defense and tech startups to establish a presence near Aberdeen Ground (APG). Proving These businesses outgrew the GroundFloor space and graduated to their own brick and mortar locations, positively impacting the Harford County defense community with their continued growth. These success stories include TENAX Technologies, Ad hoc Research, NextGen Federal Systems, and ITM4G.

# **TENAX** Technologies

One of the most successful woman-owned businesses in Harford County is TENAX Technologies. CEO Tamera Rush started her business at the GroundFloor in 2014, providing cybersecurity and engineering services to the Department of Defense. Rush says the GroundFloor was instrumental in helping her business grow.

"The GroundFloor was a great start because we had professional conference room space, an address close to APG, and collaboration with other defense contractors," Rush remarked. "There are experts to help small business in OCED such as PTAC [Maryland Procurement Technical Assistance Center], NMTC [Northeastern Maryland Tech Council], etc. Each of these organizations provides value to small businesses and to have them in one location is ideal."

When TENAX needed to expand, OCED also helped Rush to find her new, larger space at Water's Edge in Belcamp.

# Ad hoc Research

Ad hoc Research is a veteranowned company that got its start at the GroundFloor, specializing in cyber analytics, modeling and simulation, test and evaluation, and systems integration for the Department of Defense. While a GroundFloor tenant in early 2019, the company landed a \$42 million contract to support the U.S. Army Communications-Electronics Command at Aberdeen Proving Ground. Ad hoc outgrew the GroundFloor thanks to this huge deal and moved to its new location minutes away in Havre de Grace.

# NextGen Federal Systems

Having grown from one employee in Harford County to 140 nationwide, NextGen Federal Systems is an information technology and professional services company founded to support the Army's C4ISR (now C5ISR) Center of Excellence at Aberdeen Proving Ground. Division Manager Dave Bissett says the GroundFloor helped NextGen get where it is today.

"When NextGen established our business at Aberdeen Proving Ground

based on opportunities with the U.S. Army, Harford OCED provided us with resources and facilities that were critical to our early success," Bissett said. "This support helped provide us with a foundation for growth."

In addition to its Havre de Grace office, NextGen has expanded to include multiple U.S. locations providing engineering, operations, and security support to the nation's military installations.

# ITM4G

Inspection, Testing, and Maintenance 4 Government (ITM4G) is aptly named, as the company focuses on inspection, testing, and maintenance of fire protection systems for government entities. ITM4G is headquartered in Sterling, VA, but was awarded a contract at Aberdeen Proving Ground and needed space to operate locally. The GroundFloor served as a stepping stone while the company sought a permanent Harford County location.

"We began our new contract with a small crew, and our immediate requirement for space was small," Carl Taylor, the site supervisor for ITM4G in Harford County, said. "The GroundFloor provided us a space to get started and work out of as we established just what our need would be for personnel."

Starting with three employees, ITM4G expanded to a crew of 13 while at the GroundFloor and has since moved to a larger office in Havre de Grace.

# INVESTING *in* WORKFORCE

A highly skilled workforce is the hallmark of economic stability and growth. In Harford County, workforce development is a partnership between government, industry, and academia that provides customized programming to meet the needs of local employers and employees.

# **Strategic Partnerships**

To build a strong workforce pipeline, Harford County's Office of Community and Economic Development (OCED) works with strategic partners

such as Susquehanna Network, Workforce Harford Community College, and Harford County Public Schools. Connecting employers funding for with technical training is an integral part of OCED's mission. Together these efforts foster growth for a productive workforce for Harford County businesses.

THE OFFICE IN HAVRE DE GRACE IS A ONE-STOP SHOP FOR THE COUNTY'S WORKFORCE SERVICES.

Edgewood expansion was the result of a "skills gap" study commissioned by Harford County government to serve the needs of local employers. Additionally, Towson University in Northeastern Maryland offers a 2+2 program, which allows students to pursue a seamless four-year degree through both institutions.

# Harford County Public Schools

Harford County also recognizes the importance of introducing career development pathways early on in a student's education, including technical

> training. Five Harford County public high schools already have magnet or specialized programs focusing on STEM education. The North Star Pathway program, set to begin the 2020-2021 in academic year, aims for all Harford County students to graduate with some college credit or certification

# Susquehanna Workforce Network

Susquehanna Workforce Network (SWN), a private nonprofit, coordinates regional workforce development programs and services in Harford and Cecil counties. SWN provides access to jobs for county residents, customized job fairs, and recruiting events that match employers with potential workers. Recently, SWN moved their Workforce Resource Center to Harford County's OCED location in Havre de Grace, creating a one-stop shop for the county's workforce services.

# **Higher Education**

In higher education, Harford Community College offers professional training programs at the main Bel Air campus, and has now expanded programming at the Edgewood Library. The Edgewood location provides better access to career training for residents along the densely-populated Route 40 corridor. Classes offered at the facility include foundational courses, cybersecurity, and an introduction to construction. The for a trade. This program is an innovative partnership between the public school system and the community college.

### **Training Grants**

To advance the skills of current employees, Harford County OCED offers workforce technical training grants to qualified employers. Awarded on a competitive basis, these reimbursed matching funds are used to offset the cost of training for intermediate and advanced technical skills that often results in a higher pay grade or job retention. This fund can also serve as a match to secure state funds for business location, retention, or expansion projects. In addition to these grants, OCED provides information about other state and federal training resources.

# HARFORD COUNTY HALFWAY TO EVERYWHERE

ne-third of U.S. retail sales are **Growth & Expansion** now online and customers expect their orders to be delivered new quickly - sometimes later the underway: same day. This shift in buying . habits means that the location of distribution centers and access to transportation are crucial to retailers' success.

# **Location & Transportation**

Perfectly situated between New York and Philadelphia to the north and Baltimore and Washington, D.C. to the south, Harford County is "halfway to everywhere." Direct connections to I-95 and other major highways, including U.S. Route 40 and Route 1, provide easy access to one-third of the U.S. population within an overnight drive. By rail the county is served Transportation by CSX and Norfolk Southern for freight, and by AMTRAK and the MARC Train for commuters. A half-hour's drive • takes you to the Port of Baltimore, which handled a record \$59.7 billion in international cargo last year. Within an hour's drive north is Philadelphia's international airport; less than an hour south takes you to BWI.

With an ideal location and multi-modal transportation options, Harford County is thriving as a magnet for logistics management. The county currently has 24 million square feet of industrial space and a vacancy rate of 7 . percent. In 2018, this sector produced \$900 million in GDP for the county.

Moving forward, millions of square feet of e-commerce and manufacturing construction have recently been completed or are in progress.

In the Perryman area, several industrial projects are

- Tower Logistics Center will break ground before the end of 2019 for a 860,000-square-foot facility on 103 acres.
- expanding with construction of a third building, which will total 1 million square feet, representing a \$41.5 million capital investment and a projected 200 new jobs.

Eastgate also has acreage available for a fourth building, which will complete the project expected to total 2.2 million square feet. The first two buildings are already leased and operational; one by The Container Store and the other by Kuehne + Nagel.

Expanding in Edgewood:

- In April 2019, Harford County expanded the Edgewood/Joppa Enterprise Zone by 337 acres. Enterprise zones encourage development in a specified location by providing tax credits to businesses that invest in the area. The expanded Edgewood/ Joppa area includes a proposed project slated for 325 acres, totaling 2,064,800 square feet of industrial space, and 321,544 additional square feet of flex space.
- Two facilities new on Fulfillment Drive totaling 210,000 and 140,000 square warehouse feet of space were completed in 2019. The 140,000-square-foot facility is leased to AGCO, an agricultural equipment manufacturer and distributor.

# The Last Mile

Demand is increasing for buildings the size of AGCO's, in the 100,000-200,000-square-foot range, known in the logistics management business as "last mile" distribution centers. These operations supplement the larger regional distribution Eastgate Industrial Park is centers by providing same- or nextday delivery of the most commonly ordered products over the "last mile" of their distribution journey.


# Workforce Development

There are more than **11,000 jobs** in the logistics management sector in the Harford County region, with hundreds more in the pipeline. Helping to fill that pipeline is the nonprofit Susquehanna Workforce Network, which collaborates with businesses to build a highly skilled workforce and hosts recruitment fairs to connect workers and jobs. Harford Transit LINK, the county's public bus service, helps employees get to work. LINK recently added its Silver Line, serving the Perryman area, and extended weekday service hours countywide.

# THE CONTAINER STORE

became fully operational in October 2019 with a 600,000-square-foot distribution center employing more than 100 full time workers; the project brought more than \$29 million in capital investment to the county.

**KUEHNE + NAGEL's space** covers 656,800 square feet, employs nearly 150 full-time workers, and brought \$36 million in capital investment.
