NEIGHBORS WON'T APPEAL **REZONING FOR REDEVELOPMENT** OF COLGATE DIVINITY SCHOOL

The neighborhood association opposed to redevelopment plans at the former Colgate Rochester Crozer Divinity School will not appeal a judge's decision that validated rezoning, meaning developer Angelo Ingrassia is free to move forward on his project.

State Supreme Court Justice Ann Marie Taddeo ruled last month that in rezoning the property from a Development District to a Planned Development District, the proper procedures were followed with regard to the environmental impact study, traffic study, codes and the city's own comprehensive plan.

The rezoning was important to the developer because a Planned Development District provides less rigid property-use and design requirements.

City approval is still needed for several facets of project, which is called The Vistas at Highland. Through Roc Goodman LLC, Ingrassia will turn the former school's 22acre site into a residential, office and entertainment space.

Nearby resident Bob Thompson, who organized the opposition group Colgate Neighbors, said that while they were disappointed with the court's decision, there will be no appeal.

Colgate Neighbors does not oppose redevelopment of the property as long as aesthetics of the neighborhood and beauty of the campus are preserved.

Plans call for construction of two, four-story buildings for apartments, refurbishing of existing buildings, the removal of around 100 trees and creation of more parking. The blueprints must still be approved.

"The neighborhood is closely monitoring the development to ensure every procedural step is met with regard to the future planning and design of the development," Thompson said. "There are many more approvals necessary prior to the construction of a new building. Retrofitting/rehabbing the existing buildings is a much more straightforward process and we welcome appropriate reuse of those buildings."

Ingrassia has already amended original designs and agreed not to alter the sprawling south lawn that runs down to Highland Avenue. Justice Taddeo noted in her decision that the developer has already made adjustments based on the concern of neighbors.

"Our intent is to continue to work with the neighbors and interested parties as we move

forward in re-developing the Colgate property," he said in a statement back in May.

Thompson said the neighborhood group, as well as the Landmark Society of Western New York, will scrutinize plans that are brought before the city for approval.

"Any exterior modifications of the historic buildings will require a certificate of appropriateness by the Preservation Board," Thompson said. "The same would hold true for uses not covered in the original zoning change. I'm quite certain the neighborhood will be involved in monitoring and reviewing the development as things progress."

Roc Goodman LLC finalized purchase of the property in September, shortly after the school relocated to Village Gate.

Law firm suing state over pandemic restrictions

'Unduly excessive executive orders' challenged

Western New York law firm Hogan-Willig is suing New York state Gov. Andrew Cuomo and Attorney General Letitia James over executive orders that have closed many businesses to slow the spread of coronavirus.

The governor's orders have interfered with the firm's ability to practice law and serve the needs of clients and violated the constitutional rights of New York state residents, according to the complaint filed last month in U.S. District Court.

"I have no doubt that the governor was acting in what he believes to be the best interest of the people, but he doesn't get to suspend the Constitution to do that," said Steven M. Cohen, head of litigation at the firm.

Cuomo declared a state of emergency on March 7 and subsequently issued several executive orders under New York State Executive Law. The orders have directed all nonessential businesses to close while allowing businesses deemed essential to operate with fewer workers.

HoganWillig's application for essential business status was granted, but the Attorney General's Office has said in letters to the firm that it is not doing

Buffalo officers suspended after man, 75, is shoved

BUFFALO (AP) - Prosecutors investigated Friday after a television crew captured a police officer in Buffalo shoving a 75-year-old man who then falls and cracks his head, a confrontation that resulted in the suspension of two officers.

The video from WBFO of Thursday night's encounter, which happened near the conclusion of protests over the death of George Floyd in Minnesota, quickly sparked outrage.

It showed an officer pushing a man

who approached a line of officers clearing demonstrators from Niagara Square around the time of an 8 p.m. curfew. The man falls backward and hits his head on the pavement. Blood leaks out as officers walk past.

The mayor, Byron Brown, said in a statement that the man, who hasn't been publicly identified, was in serious condition. A hospital official said he was "alert and oriented," Erie County Executive Mark Poloncarz tweeted Fri-

day morning.

"Let's hope he fully recovers," Poloncarz said.

The video immediately generated outrage, including among elected officials, despite lacking the racial element that made the death of Floyd, a black man who died after a white police officer pressed a knee on his neck for several minutes, such a flashpoint.

The officer and the man in the Buffalo video both appear to be white. Gov. Andrew Cuomo endorsed the suspensions, tweeting that what was seen on video was "wholly unjustified and utterly disgraceful."

The police commissioner suspended two police officers without pay, the mayor said.

The District Attorney's Office "continues to investigate the incident," officials said in a news release, but the victim could not talk to investigators Thursday night.

Buffalo police initially said in a statement that a person "was injured when he tripped & fell," WIVB-TV reported, but Capt. Jeff Rinaldo later told the TV station an internal investigation was opened.

"When I saw the video, certainly, it was incredibly distressing and very disappointing. You don't want to see anything like that," Brown told WIVB-TV on Friday.

The office of state Attorney General Letitia James tweeted that officials there were aware of the video. U.S. Sen. Charles Schumer called for an investigation, according to a statement reported by WIVB-TV.

"The casual cruelty demonstrated by Buffalo police officers tonight is gut-wrenching and unacceptable," John Curr, the Buffalo chapter director for the New York Civil Liberties Union, said in a statement, adding that it should be a "wake-up call" for city leaders to address police violence.

enough to reduce the potential impact of COVID-19.

The lawsuit claims that the state's Executive Law does not comply with the New York State Constitution because it authorizes Cuomo to issue executive orders with binding legal authority, without the involvement of the state Legislature.

Even if they are constitutional, the lawsuit claims, Cuomo's orders are not reasonably necessary to combat COVID-19.

"While measures taken by Governor Cuomo may have initially been undertaken with the best intentions, the New York State Constitution does not permit the Governor to take unilateral actions, even in times of emergency. Executive Law § 29-a has been invoked as the basis for Governor Cuomo's actions in issuing the Executive Orders, but the powers to make the laws are only within the purview of the New York State Legislature," according to the suit. "This "separation of powers" is fundamental to all levels of government in the United States, and cannot be easily overturned, even when the State is faced with a crisis," the suit claims.

The executive orders violated Hogan-Willig's rights under the United States Constitution, including its rights to due process, to be free from a governmental seizure of property without just compensation and to be afforded equal protection under the law, among others, according to the complaint. "The available data from studies performed throughout the United States does not support the legitimacy of the defendants' continuing actions in issuing arbitrary, unduly excessive executive orders having the full force and effect of law upon individuals and business located within the state of New York, largely in violation of the individuals' and business' state and federal Constitutional rights," the suit claims

US moves forward with plan to end wild bird protections

BILLINGS, Mont. (AP) — The Trump administration moved forward Friday with plans to scale back a century-old law protecting most American wild bird species despite warnings that billions of birds could die as a result.

Officials said in a draft study of the proposal that it could result in more deaths of birds that land in oil pits or collide with power lines or other structures. The study did not put a number on how many more birds could die but said the effects could be "significant."

Former U.S. Fish and Wildlife Service Director Dan Ashe and independent scientists have said the change could cause a huge spike in bird deaths — potentially billions of birds in coming decades — at a time when species across North America already are in steep decline.

The proposal would end the government's decades-long practice of treating accidental bird deaths caused by industry as potential criminal violations under the Migratory Bird Treaty Act. More than 1,000 species are covered under the law.

Industry sources kill an estimated 450 million to 1.1 billion birds annually, out of an overall 7.2 billion birds in North America, according to the U.S. Fish and Wildlife Service and recent studies.

The 1918 migratory bird law came af-

ter many U.S. bird populations had been decimated by hunting and poaching — much of it for feathers for women's hats.

Over the past half-century, the law also was applied against companies that failed to prevent foreseeable bird deaths, such as oil companies that did not put netting over toxic waste pits despite warnings from federal officials.

However, the Trump administration has said the deaths of birds that fly into oil pits, mining sites, telecommunications towers, wind turbines and other hazards should be treated as accidents not subject to prosecution.

A final decision is expected following a 45-day public comment period.

A Department of Interior legal decision in 2017 already had effectively ended criminal enforcement under the act during Trump's presidency.

National Audubon Society President David Yarnold said the administration was ignoring the potential devastation to some species from scaling back protections and siding with corporations over the environment.

"While America is in turmoil, the Trump administration is continuing its relentless war on nature," Yarnold said.

Eight states led by New York and numerous conservation groups including Audubon have challenged the 2017 decision in U.S. District Court.

Minnesota eyes changes to police-involved deaths

MINNEAPOLIS (AP) — Minnesota's county attorneys want to give the state attorney general the authority to handle all cases of police-involved deaths.

The Minnesota County Attorneys Association voted Thursday in transferring that power during an emergency meeting, which included Attorney General Keith Ellison. The attorney general is leading the state's case against the four police officers involved in George Floyd's death instead of the Hennepin County Attorney's Office.

State lawmakers would need to pass legislation during this month's special session to give the attorney general the ongoing authority.

The county attorneys are also calling on the Legislature to provide additional funding to the state Attorney General's Office and create a unit within Minnesota Bureau of Criminal Apprehension to investigate police killings of civilians.

"If this is the path the Legislature and governor choose to take, my office will accept the responsibility," Ellison said. "But it must come with resources sufficient to do the job thoroughly and to do justice in the way Minnesotans have a right to expect."

Ellison is one of 18 Democratic attorneys general who are asking Congress to grant their offices "clear statutory authority under federal law" to investigate "unconstitutional policing by local police departments" in their respective states, the Star Tribune reported.

Court rules against Sydney protest due to virus fear

SYDNEY (AP) — An Australian court sided with police in ruling Friday that a Black Lives Matter protest planned for Sydney poses too much risk for spreading the coronavirus and cannot be held.

Thousands of people were expected to rally in Australia's largest city on Saturday afternoon to honor George Floyd and to protest against the deaths of indigenous Australians in custody.

But New South Wales state Supreme Court Justice Des Fagan ruled the rally was not an authorized public assembly. Fagan said he understood the rally was designed to coincide with similar events in other countries.

"I don't diminish the importance of the issues and no one would deny them in normal circumstances," he said. "No

U.S. unemployment drops to 13.3%

WASHINGTON (AP) — The U.S. unemployment rate fell unexpectedly in May to 13.3% as states loosened their coronavirus lockdowns and businesses began recalling workers faster than economists had predicted.

The government said Friday that the economy added 2.5 million jobs last month, driving unemployment down from 14.7% in April.

For weeks, economists had been warning that unemployment in May could hit 20% or more, rivaling what was seen during the depths of the Depression in the 1930s.

Once again, the Labor Department acknowledged making errors in how it classified people as employed and said the real May rate is worse than the numbers indicate. But the government made the same mistakes in

April, and together the figures still show the job market is improving.

The May job gain, which confounded economists' expectations of another round of severe losses, suggests that thousands of stores, restaurants, gyms and other companies reopened and rehired more quickly than many analysts had forecast.

"We are witnessing the easiest phase of growth as people come off temporary layoffs and come back to their employers," said Harvard University economist Jason Furman, who led the White House Council of Economic Advisers during the Obama presidency. "And once employers are done recalling people, the much harder, longer work of recovery will have to proceed."

Virginia city removes 176-year-old slave auction block

FREDERICKSBURG, Va. (AP) — A 176-year-old slave auction block has been removed from a Virginia city's downtown.

The 800-pound (363-kilogram) stone was pulled from the ground at a Freder-

icksburg street corner early Friday after the removal was delayed for months by lawsuits and the coronavirus pandemic, The Free Lance-Star reported.

The weathered stone was sprayed with graffiti twice and chants of "move the block" erupted this week during local demonstrations over the death of George Floyd in Minneapolis, city officials said in a statement announcing the removal.

A local chapter of the NAACP called for the stone's removal in 2017, saying it was a relic of "a time of hatred and degradation" that was allowed to be displayed at a main thoroughfare in the city.

In 2019, the City Council voted in favor of its removal and relocation to the Fredericksburg Area Museum, and a judge upheld that decision in February after two businesses near the auction block sued to stop the relocation.

The process was held up after one of the businesses, a commercial building owner, asked the Virginia Supreme Court to bar the removal while her decision was being appealed, the newspaper said.

The museum now plans to display the knee-high stone in an exhibit chronicling the "movement from slavery to accomplishments by the local African American community," the Free Lance-Star said.

Tennessee attorney pleads guilty to defrauding clients

MEMPHIS, Tenn. (AP) - A Tennessee attorney faces up to 30 years in prison after he pleaded guilty to stealing more than \$600,000 from clients by settling cases without telling them and forging their signatures on settlement checks.

The U.S. attorney's office in Memphis said 50-year-old Michael Skouteris has pleaded guilty to bank fraud in connection with a scheme to defraud clients.

Prosecutors said Skouteris defrauded clients in cases dating from 2011 to 2016. Prosecutors have said the cases involved nursing home neglect, medical malpractice, personal injury and worker's compensation.

Prosecutors said Skouteris forged endorsements on settlement checks made jointly payable to him and the client. He then deposited the checks into his bank accounts.

Sentencing is set for Sept. 24, the U.S. attorney's office said Tuesday.

Better balance needed between safety and ability to earn living

We hope the U.S. Supreme Court chooses to hear oral arguments in a case involving two Warren County businesses' fight against Pennsylvania Gov. Tom Wolf's business closure order.

The businesses ask a question regarding gubernatorial power that deserves a national answer.

To quickly recap, the case was brought by five entities, including the Blueberry Hill Golf Club and the Caledonia Land Company of Clarendon, after Wolf ordered the closure of all non-life-sustaining businesses in response to the COVID-19 pandemic. The state Supreme Court sided in favor of the state and the business closures.

While the U.S. Supreme Court has denied an application for a stay of the order, it has yet to act on a Writ of Certiorari, or cert petition, the businesses also filed asking the nation's highest court to hear the case. Four Pennsylvania counties have now filed an amicus curie, or friend of the court, brief supporting the Warren County businesses.

The counties argue that the actions of Wolf and Pennsylvania Health Secretary Dr. Rachel Levine have "substantially restricted the rights of its citizens," citing four specific amendments — the First, Fourth, Fifth and 14th.

"The governor decided by fiat what was life-sustaining and what was not life-sustaining," the counties assert. "The governor offered no guidance relative to the proclamation, and did not see fit to submit such classification to the General Assembly for guidance and approval. What is more, the classifications imposed by the Governor are shocking when one considers the similarity of the business activity between some life-sustaining business activity and some non-life-sustaining business activity."

The counties make an argument that sounds eerily familiar to those of pro-business groups across the country, including New York state. What are the limits of gubernatorial power when it comes to depriving business owners and their employees of their ability to earn a living? Should there be a better balance between safety and

A justification for unrest? Look no further than the Bible and the Founding Fathers

The civil unrest seen across the United States following the killing of George Floyd brings to the fore the Rev. Martin Luther King Jr.'s famous observation that "a riot is the language of the unheard."

Taken from his 1968 speech "The Other America," King condemned the act of rioting, but at the same time challenged audiences to consider what such actions say about the experience of those marginalized in society.

"Social justice and progress are the absolute guarantors of riot prevention," King said.

In other words, peace cannot exist without justice. This conviction has deep roots in Christian thought; it can be traced to the authors of the Bible and early Jewish and Christian communities.

More recently, the Episcopal bishop of Washington, Mariann Budde, said of the current protests that the church aligns "with those seeking justice." The comment followed a controversial visit in which President Trump held a Bible in front of St. John's Episcopal Church — an act preceded by the dispersal of a crowd of protesters and priests tending to them with the use of tear gas.

As scholars of biblical texts and religion and culture, we believe that understanding how often violent unrest informed both early Christianity and the foundational stories of the United States itself can guide us in this current period of turmoil.

Israelite injustice

Deep rooted dissatisfaction with prevailing social injustice and actions against such inequity isn't new. It would have been a familiar theme to the people who wrote the Bible and it is reflected in the texts themselves. ancient Christian sources viewed these goods as "fair wages," in the words of the scholar James Kugel just repayments for the Israelites' years of slave labor.

Archaeological evidence points to a generally different origin story for the ancient nation of Israel — though one also of social unrest. According to some scholars, the settlement stemmed from the rebellion and regrouping of people who fled the collapse of large, urban areas in the southern Levant, modern-day Israel and Palestine.

The biblical impulse toward social justice appears especially in the prophets of the Old Testament, such as Amos and Isaiah whose call for justice and equality is a constant theme. It is little wonder, then, that they were cited in the context of the modern-day civil rights movement. King cited prophets from the Bible repeatedly in his "I Have a Dream" speech. When he talked of "justice" rolling "down like waters, righteousness like an ever flowing stream" and "crooked places" being "made straight," he is pulling directly from the Books of Amos and Isaiah.

Early Christian unrest

The New Testament also attests to experiences of social unrest in early Christianity.

In the Book of Matthew, Jesus is quoted as saying, "I have not come to bring peace, but a sword." And in confronting money changers in the Temple of Jerusalem, Jesus overturns the tables and whips the money changers for their unjust actions.

To some this might provide justification for the destruction of property. Others, however, observe that Jesus claims that the Temple belongs to "my father's house" — meaning his family — and as such cannot be taken as justification for destroying someone else's possessions.

Unrest lies at the heart, for example, of the biblical story about the origins of ancient Israel. As recounted in the books of Genesis and Exodus, Abraham's grandson Jacob travels to Egypt for food in a time of famine. After Jacob's descendants are made slaves, Moses delivers the Israelites from bondage and leads them back to the promised land.

Here, the event that sparks liberation is Moses' witnessing of the oppression of the Israelites. The Book of Exodus details how they left Egypt with gold and silver procured in somewhat uncertain circumstances from their Egyptian neighbors. The manner of this acquisition would be a topic of discussion in biblical interpretation for centuries, for fear that it looks like plunder.

However, both ancient Jewish and

It is clear from many passages that the religious movement had a primary concern to care for the oppressed and that in that context, unrest can sometimes be justified.

Nonetheless, some parts of the Bible have been used to justify the quelling of social unrest. Jeff Sessions, former attorney general of the United States, recently appealed to Romans 13 when claiming that enforcement of strict immigration reform was the rule of law: "I would cite you to the Apostle Paul and his clear and wise command in Romans 13, to obey the laws of the government because God has ordained them for the purpose of order." Biblical scholars dispute this inter-

pretation, noting that the word "law" appears only once in Romans 13, when Paul states that "love does no

How much police brutality is in our wallet?

The protests and riots popping up around the country present the issue of how we value lives, spurred on by the death of George Floyd, a demise that's been called — properly, in my opinion murder by authorities. Police violence will never end in the United States as long as we think black people and their lives are disposable.

Who matters and who doesn't is part of what's happening in the streets these days. Another reason why police brutality persists is that its perpetrators never have to pay for it. Claims for damages from violence by law enforcement are borne by taxpayers as police union members skip off with their pensions.

If state and local governments paid each successful claim of brutality or corruption out of police pension funds, this violence would go the way of dial-up internet; no one would use it or even think about it except in hindsight as they talk about how common it once was. Police misconduct hurts the police the least. Take the case of the Beatrice Six, people from Beatrice, Nebraska. Local law enforcement was convinced that they had murdered someone in 1985 even though they had no con-

Direct shifting of judgment has happened in other places. In Inkster, Michigan, in 2015 a \$1,377,500 settlement with a man who was beaten severely at a traffic stop caused property owners to have to pony up about \$178.67 each to cover the tab for what the officer did.

It may have happened to you.

"The public knows nothing about it," former New Orleans Mavor Marc MoBut that's the problem with these alleged good cops; they're not that good if they let the bad cops keep choking and shooting people. Putting pensions in danger would cause the cops to police themselves more.

Don't be fooled that saving these pension funds from liability will decimate police forces, that they'll simply strike, refuse to work without such provisions in their contract, and you'll be stuck without a local force. Public employee labor stoppages are a possibility in only 11 states, and they're unlikely at that. In 39 states, police won't be able to leverage a pension protection into their contracts if government representatives won't allow it. The state or municipality can simply hire other people who will agree to be responsible for their own actions.

wrong to a neighbor; therefore love is the fulfilling of the law."

Civil religion and unrest

Biblical passages have been used by American politicians for as long as there has been a United States.

As historian James Byrd has argued, the American revolutionaries claimed the apostle Paul gave Christians the license to resist tyrants using violent means.

In addition to drawing on the Bible, the Founding Fathers also produced a new sacred canon to justify unrest in the event of injustice - founding stories referred to by scholars as "civil religion."

Think, for instance, of the Boston Tea Party dumping tea into the harbor in a protest against an unjust tax. The national narrative sees this as heroic.

The fact that injustice requires action is similarly supported by the Declaration of Independence. It frames the relationship between Britain and the colonies as one of "repeated injuries and usurpations"

which the colonists have tried to solve, to be "answered only by repeated injury."

Repeated injustice, then, was grounds for revolution.

'Deferred dreams explode'

Martin Luther King did not call for violence, but said "peace is not merely the absence of this tension, but the presence of justice." He also stated that if peace meant silence in the face of injustice, then "I don't want peace."

King did not think that riots were the best approach to take. But he warned against condemning them, unless society also condemned the conditions that brought riots about.

As one pastor in Minneapolis put it, referencing the poet Langston Hughes as she assessed the protests: "Deferred dreams explode."

NEW YORK STATE SUPREME COURT, APPELLATE DIVISION, FOURTH JUDICIAL DEPARTMENT

CRIMINAL POSSESSION OF A WEAPON

Inoperable – Intent to possess operable weapon People v. Almodovar KA 16-01315 Appealed from Supreme Court, Monroe County

BACKGROUND: The defendant appealed from his conviction of criminal possession of a weapon and menacing. The conviction arose from his possession of a firearm and his confrontation with the father of a child regarding a prior incident that occurred less than a week before in which the defendant purportedly tried to remove the child from her preschool when he had no authorization to do so.

RULING: The Appellate Division affirmed.

The court held that the record supported his conviction. While there was no dispute that the weapon was not operable, the defendant's statements to the police established that he was aware that the father of the child was looking for him as a result of the prior incident, which made the defendant scared and galvanized him to purchase a firearm from a man on a dead-end street; the firearm was loaded, and the defendant did not determine it was inoperable due to a missing firing pin until after the underlying incident.

NEW YORK STATE SUPREME COURT, APPELLATE DIVISION, FOURTH JUDICIAL DEPARTMENT

DRIVING WHILE INTOXICATED

Consciousness of guilt – Circumstantial evidence People v. Bradbury KA 17-00964 Appealed from Supreme Court, Ontario County

BACKGROUND: The defendant appealed from a judgment convicting her of two counts of felony driving while intoxicated. The defendant was arrested when a motorist observed her vehicle stuck in the brush 20 to 30 feet from the roadway. The motorist had offered assistance, but the defendant said she was all right and did not want to call 911. The responding police officer interviewed the defendant who told him that she left the bar with a man who crashed the car and left.

RULING: The Appellate Division reversed and dismissed the indictment. The court

held the conviction was against the weight of evidence. The Appellate Division noted that the defendant's request that the passing motorist not call 911 constituted evidence of consciousness of guilt, it is well settled that consciousness of guilt evidence is a weak form of evidence. The failure to provide more detailed description did little to disprove the defendant's hypothesis of innocence, given the general nature of the questions posed to her. Finally, the police officer's testimony that the driver's seat position was not consistent with a car being driven by the description provided by the defendant, but it is circumstantial without more evidence.

CHILD CUSTODY

Best interests of the child – Factor analysis Alwardt v. Connolly CAF 19-00538 Appealed from Family Court, Genesee County

BACKGROUND: The petitioner father appealed from an order that denied his petition seeking to modify a prior order of custody by awarding him primary residential custody of the subject child.

RULING: The Appellate Division reversed. The court held that court's custody determination lacks the requisite sound and substantial basis in the record. The court noted that the only factor that weighs in favor of the mother is the existing custody arrangement. While the child has a brother living at the mother's house, that is not a factor that favors the mother because both parties have children. While in the mother's custody, the child performed poorly at school and experienced a significant increase in her depression. Further, the mother's work schedule required the child to be up at 5 a.m. and taken to a relative's house for two hours before going to school. The mother admitted that she is unable to assist the child with schoolwork or attend to the child's medical and mental health counseling appointments. Finally, the child expressed a desire to live with her father.

UNITED STATES COURT OF APPEALS FOR THE SECOND CIRCUIT

VICTIMS OF TRAFFICKING ACT

Special assessment calculation – Sentencing – Abuse of discretion United States v. Haverkamp 18-3735 Judges Sack, Parker and Chin

BACKGROUND: The defendant appealed from his sentencing of 10 years and one month in prison, five years of supervised release, a \$200 special assessment and a \$10,000 assessment. The defendant had pled guilty to one count of distribution and receipt of child pornography. The defendant contends that his sentence is substantively unreasonable and the \$10,000 special assessment was in error, and that a computer monitoring condition of his supervised release was overbroad.

RULING: The Second Circuit affirmed in part, vacated in part and remanded. The court held

that the record demonstrates that the district court properly considered the nature and circumstances of the offense when fashioning the sentence imposed wherein it noted the volume of messages, videos, and photographs the defendant exchanged and emphasized that his conduct went beyond the trading of existing child pornography. The defendant's conduct included the solicitation of the production of child pornography from minors over social media, including his sexual relationship with a 14-year-old boy. The Second Circuit held that Section 3014 of the Victims of Trafficking Act meant to apply a special assessment of \$5,000 per offender, not per count.

UN agency: Iran violating all restrictions of nuclear deal

VIENNA — Iran has continued to increase its stockpiles of enriched uranium and remains in violation of its deal

heavy water.

The nuclear deal promised Iran economic incentives in return for the curbs on its nuclear program. President Donald Trump pulled the U.S. out of the deal unilaterally in 2018, saying it needed to be renegotiated. Iran has since slowly violated the restrictions to try and pressure the remaining nations to increase the incentives to offset new, economy-crippling U.S. sanctions. The ultimate goal of the JCPOA is to prevent Iran from developing a nuclear bomb. Since the U.S. withdrawal, Iran has stockpiled enough uranium to produce a weapon, although the government in Tehran insists it has no such goal and that its atomic program is only for producing energy. According to the Washington-based Arms Control Association, Iran would need roughly 1050 kilograms (1.16 tons) of low-enriched uranium - under 5% purity - and would then need to enrich it further to weapons-grade, or more than 90% purity, to make a nuclear weapon.

However, that doesn't mean Iran would immediately rush toward building a

new coronavirus pandemic, the IAEA said it has maintained its verification and monitoring activities in the country, primarily by chartering aircraft to fly inspectors to and from Iran.

It cited "exceptional cooperation" from

with world powers, the United Nations' atomic watchdog said Friday.

The International Atomic Energy Agency reported the finding in a confidential document distributed to member countries and seen by The Associated Press.

The agency said that as of May 20, Iran's total stockpile of low-enriched uranium amounted to 1,571.6 kilograms (1.73 tons), up from 1,020.9 kilograms (1.1 tons) on Feb. 19.

Iran signed the nuclear deal in 2015 with the United States, Germany, France, Britain, China and Russia. Known as the Joint Comprehensive Plan of Action, or JCPOA, it allows Iran only to keep a stockpile of 202.8 kilograms (447 pounds).

The IAEA reported that Iran has also been continuing to enrich uranium to a purity of up to 4.5%, higher than the 3.67% allowed under the JCPOA. It is also above the pact's limitations on

With the nuclear deal in place, Iran's so-called breakout time — the period Tehran would need to build a bomb if

bomb if all the materials were in place.

Before agreeing to the nuclear deal, Iran enriched its uranium up to 20% purity, which is just a short technical step away from the weapons-grade level of 90%. In 2013, Iran's stockpile of enriched uranium was already more than 7,000 kilograms (7.72 tons) with higher enrichment, but it didn't pursue a bomb.

As the country has expanded its nuclear program, Iran has been open about the violations and continues to allow inspectors for the U.N. atomic agency access to facilities to monitor its operations.

It is now in violation of all restrictions outlined by the JCPOA, which Tehran says it hopes will pressure the other nations involved to increase economic incentives to make up for hard-hitting sanctions imposed by Washington after the U.S. withdrawal.

Though Iran has been hard hit by the

authorities in Austria, where it is based, and Iran in facilitating the operation.

The agency raised concerns, however, about access to two of three locations it identified in March as places where Iran possibly stored undeclared nuclear material or undertook nuclear-related activities without declaring them to international observers.

Activities at all three sites are thought to have been from the early 2000s. The IAEA said in its current report that it had determined that one site had undergone "extensive sanitization and leveling" in 2003 and 2004 and there would be no verification value in inspecting it.

It said Iran has still blocked access to the other two locations, one of which was partially demolished in 2004 and the other at which the agency observed activities "consistent with efforts to sanitize" the facility from July 2019 onward.
